Wallace's Farm and **Dairy** Duke University Press In a work of encyclopedic scope, International Trotskyism, 1929-1985 is sure to become the definitive reference work on a movement that has had a significant impact on the political culture of countries in every part of the world for more than half a century.

Renowned scholar Robert I. Alexander has amassed. from disparate sources, an unprecedente d amount of primary and secondary material to provide a documentary history of the origins, development, and nature of the Trotskyist movement around the world. Drawing on interviews and correspondenc e with Trotskyists, newspaper reports and pamphlets, historical writings including the

annotated writings of Trotsky in both English and French. historical memoirs of **Trotskyist** leaders, and documents of the Fourth International. Alexander recounts the history of the movement since Trotsky's exile from the Soviet Union in 1929. Organized alphabetically in a doublecolumn. country-bycountry format this book charts the formation and growth of Trotskyism in more than

sixty-five countries. providing biographic information about its most influential leaders. detailed accounts of Trotsky's personal involvement in the development of the movement in each country, and thorough reports of its various factions and splits. Multiple chapters are reserved for countries where the movement was more active or fully developed and various

chapters are organized around crucial thematic issues, such as the Fourth International. The chapters are followed by extensive name. organization, publication, and subject indexes, which provide optimal access to the wealth of information contained in the main body of the work. Sealy & Worthington's Cases and Materials in Company Law Mehring Books Committee meets to hear initial

testimony dealing with attempts of militian revolutionarie s to subvert the military. Discrediting the Red Scare Springer Nature COINTELPRO. An acronym for Counterintellig ence Program, this is the code name the FBI gave to the secret operations aimed at five major social and political protest groups--the Communist party, the Socialist Workers Party, the Ku Klux

Klan, black nationalist hate groups, and the New Left movement. Spying on America, the first book to chronicle all five of the operations, tells the story of how the FBI, from 1956 until COINTELPRO's exposure in 1971, expanded its domestic surveillance programs and increasingly employed questionable, even unlawful. methods in an effort to disrupt what amounts to virtually our

entire social and political protest movement. Violations of citizens' constitutional rights were rampant, and the secret operations actually resulted in a number of deaths. At the time, neither the public nor the news media knew anything about COINTELPRO. In vivid detail, Spying on **America** demonstrates that the system of checks and balances designed to prevent such

occurrences was simply not functioning-until an illegal act uncovered the secret activities. The book opens with the daring raid of a Media, Pennsylvania FBI office by a group that adeptly used its booty-about 1,000 classified documents--to make COINTELPRO operations public. The burglars, who called themselves the Citizen's Commission to Investigate the FBI. used sophisticated

methods (the FBI never caught up with them). releasing copies of incriminating documents to the media at carefully timed intervals. Spying on America draws on newspaper and magazine articles. interviews with many of the people involved, and FBI memos to trace the historical beginnings and operating methods of COINTELPRO efforts against each of the five targeted groups. In

vivid detail. the author recreates the reactions of the bureau-including the subsequent policy changes--as well as the response of the news media and the resulting shift in public attitudes toward the FBI. Finally, Davis looks at the possibility of similar operations in the future. In the context of our current, heightened state of sociopolitical awareness, it is difficult to comprehend how so many

unlawful deeds could have been committed without the public's knowledge. Spying on America makes us aware of how easily such activities can occur--and in doing so, helps us prevent them from happening again. thick of World War II. American soldier lames Kutcher was hit by a German mortar shell and lost both of his legs. Back home. rehabilitated and given a iob at the Veterans' Administration , he was soon to learn that his battles were far from over. In 1948. in the throes of the postwar Red Scare, the hysteria over perceived Communist threats that marked the Cold War, the government

moved to fire Kutcher because of his membership in a small. left-wing group that had once espoused revolutionary sentiments. Kutcher's eight-year legal odyssey to clear his name and assert his First Amendment rights, described in full for the first time in this book, is at once a cautionary tale in a new period of patriotic oneupmanship, and a story of tenacious patriotism in

its own right. The son of Russian immigrants, James Kutcher came of age during the Great Depression. Robbed of his hope of attending college or finding work of any kind, he joined the Socialist Workers Party, left-wing and strongly anti-Soviet, in his hometown of Newark. When his membership in the SWP came back to haunt him at the height of the Red Scare. Kutcher took up the fight

against efforts to punish people for their thoughts, ideas, speech, and associations. As a man who had fought for his country and paid a great price, had never done anything that could be construed as treasonous. held a low level clerical position utterly unconnected with national security, and was the sole support of his elderly parents, Kutcher cut an especially sympathetic figure in the

drama of Cold War witchhunts. In a series of confrontations . in what were highly publicized as the "case of the legless veteran." the federal government tried to oust Kutcher from his menial Veterans' Administration job, take away his World War II disability benefits, and to oust him and his family from their federally subsidized housing. Discrediting the Red Scare tells the story of his long

legal struggle in the face of government persecution—t hat redoubled after every setback until the bitter end. The SWP. Mehring Books Passed in June 1940. the Smith Act was a peacetime anti-sedition law that marked a dramatic shift in the legal definition of free speech protection in America by criminalizing the advocacy of disloyalty to the government by force. It also criminalized the acts of

printing, publishing, or distributing anything advocating such sedition and made it illegal to organize or belong to any association that did the same. It was first brought to trial in July 1941, when a federal grand jury in Minneapolis indicted twenty-nine Socialist Workers Party members. fifteen of whom also belonged to the militant Teamsters Local 544. Eighteen of the

defendants were convicted of conspiring to overthrow the government. Examining the social. political, and legal history of the first Smith Act case. this book focuses on the tension between the nation's cherished principle of free political expression and the demands of national security on the eve of America's entry into World War II. Based on newly declassified

government documents and recently opened archival sources. Trotskyists on Trial explores the implications of the case for organized labor and civil liberties in wartime and postwar America. The central issue of how Americans have tolerated or suppressed dissent during moments of national crisis is not only important to our understanding of the past, but also remains a

pressing concern in the post-9/11 world. This volume traces some of the implications of the compromise between rights and security that was made in the midtwentieth century, offering historical context for some of the consequences of similar bargains struck today. the properties of very different systems, from thin inorganic layers to ripening cheese to biological systems.
