[...] If the property owner and the assessor fail to agree on the assessed value of the residential property, the owner may proceed to the formal Reference process. [...] Once the Notice of Reference is filed, both the property owner and Assessment Services need to fulfill certain obligations related to the challenge of the assessed value. [...] The property owner and Assessment Services have opposing positions at this point and a third party, the Assessment and Planning Appeal Board becomes involved to review the correctness of the "real and true value" of the property.
